Using these experiences, she became an advocate for various family members, refugees, and immigrants in healthcare settings. She created a resource list to facilitate new immigrants' transition to life in America.

She is married and a mother of three children, Wabi (29), Kahwit (25), and Kemi (19). In her free time, she loves listening to world music and enjoys experiencing new cultures through travel.
